A. Kayla Danks Retirement

Plaque presented. Ms. Kayla Danks, (White Blossom - "ma naga bagi Ohxaadish"), is an enrolled member of the Three Affiliated Tribes of the Fort Berthold Indian Reservation. Ms. Danks worked for the Bureau of Indian Affairs for more than 35 years. She began her federal career working for the BIA in June of 1986 at the Great Plains Regional Office, Division of Real Estate Services. From 1994 to 2000, Ms. Danks served as the Realty Officer at Central California Agency, and, later as a Realty Specialist at the Sacramento Regional Office. During the time that she worked in California, she was instrumental in processing many large land-into-trust acquisitions (both gaming and non-gaming). These land acquisitions established larger and new reservations for the California Tribes that were unconstitutionally terminated. Then in 2000, Ms. Danks accepted a position in Washington D.C. serving as a Senior Realty Specialist. While working as Senior Realty Specialist from 2000 to 2005, Ms. Danks worked on the Department of Interior's workgroup that overhauled the residential, business, and solar resource leasing regulations at 25 CFR 162. Ms. Danks also worked on National Policies, including the Bureau of Indian Affairs', Land Acquisition and Leasing Handbooks. From 2005 to 2008, Ms. Danks served as a Realty Specialist at the Western Regional Office in Phoenix, Arizona, continuing to work on all types of real estate transactions and she served on a long-term detail as the Superintendent, Fort Yuma Agency, and Realty Officer, Gila River Agency. Then in 2008, Ms. Danks accepted the position as Regional Realty Officer, Midwest Region, Fort Snelling, Minnesota, and she also served on a long-term detail as the Deputy Regional Director at the Midwest Region. During her term at the Midwest Region, 2008 to 2014, Ms. Danks managed the Regional Real Estate Program by issuing appeal decisions, policy, and providing technical assistance to the Tribes in Minnesota, Wisconsin, and Michigan. During this time, she was instrumental in processing many land-into-trust acquisitions, both gaming and non-gaming. Ms. Danks even had to the opportunity to take an Island, with an historical light house, into trust, and was instrumental in the settlement of a 100year old trespass. Ms. Danks also served on the Department of Interior's workgroup that finalized the new rights of way regulations at 25 CFR 169. In May of 2014, Ms. Danks was honored to accept the position as Superintendent at Fort Berthold Agency. She has served in this position for the past seven and a half years. During this time, she has managed all facets of the Fort Berthold Agency, but most notably the unprecedented oil and gas boom on the Fort Berthold Indian Reservation which has resulted in the distribution of over 5 Billion dollars in royalties. One of her first projects at FBA, was to ensure that all landowners received not less than fair market



value for their land transactions. Her regulatory background served useful when she implemented the new rights-of-way regulations which cleared up the oil and gas rights-of-way backlog. In 2016, Ms. Danks served as the Election Board Chairwoman when the BIA conducted the Secretarial Election that established the latest amendment to the Three Affiliated Tribes Constitution. Ms. Danks conducted landowner outreach by providing land transaction training to the landowners or by attending meetings to provide technical assistance, including Tribal Council meetings, the annual Tribal Energy Oil and Gas Summit, the Western Dakota Energy Association meeting or landowner association meetings. Ms. Danks was instrumental in finalizing the long-term space requirements to relocate the Fort Berthold Agency Office to the upcoming new Tribal Capitol Grounds development. Of all the positions that Ms. Danks held, she has found working for the Fort Berthold Agency to be the most challenging and the most rewarding.
